- I. Entry deadline **Monday, March 4, 2019.**
 - A. First entry fee is \$550.
 - B. Additional entries are \$350.
 - C. Remodeler must be a member of the Remodelers Council of Lincoln to participate in the Tour of Remodeled Homes. Should a non-member wish to participate, they must submit their application for membership in time to be approved and become a member prior to submission of contract to enter the Tour of Remodeled Homes. Participation is open to all Remodelers Council members in good standing.
- II. I agree to submit all of the following additional materials by Monday, March 4, 2019:
 - A. Information sheet about the project giving a description and a map showing the location of the entry.
 - B. Photo or drawing of the **completed** project.
- III. The project must showcase a change in shape, form, or function of the residence, and not have been shown to the public before.
- IV. The purpose of the Tour of Remodeled Homes is to increase exposure of our participating members; to promote a more professional image and increase our credibility; to benefit the public by stimulating an interest in remodeling existing homes; and to showcase our quality workmanship and new products while increasing the membership of the Remodelers Council.
- V. I agree to provide at least two people, with one person in each of the remodeled areas and one at the main entrance to take tickets, the full hours of the Tour of Remodeled Homes.
- VI. I agree not to open the entered home to the public prior to the Tour of Remodeled Homes.
- VII. I agree that the Remodelers Council and/or the Home Builders Association of Lincoln will not be held liable for any loss due to theft, vandalism, or personal injury.
- VIII. This contract is null and void unless at least five projects are entered by **March 4, 2019.**
